# 30/20 ALZHEIMER'S CAFÉ & DEMENTIA AWARENESS PARTNERSHIP

### 36/20 FINANCES

## 37/20 GRANT APPLICATIONS

- 8.1 The Council considered a grant application from the East Cowes VE Day Celebration Crafters for £395 to cover the cost of storage boxes and resources to complete community crafting projects.
- 8.2 The Council considered a grant application from Cowes Sailability Club for Kingston Farmhouse residents. £1500.00 was requested to cover the cost of 6 boat trips for 10 residents from East Cowes with physical and learning disabilities.
- 8.3 The Council considered a request from Laura Reid, Youth Worker for a grant of £12000, to fund the youth service for 20/21. Councillors discussed this and felt that as this grant had been at the same level for the past few years and that there should be a supplementary grant of £2000 available, if required. This amount (£14,000) had been reserved in the 20/21 budget.

**Resolved:** To approve the grants to the East Cowes VE Celebration Crafters of £395.00, Cowes Sailability Club of £1500.00. To approve the youth grant of £12,000.00 for the financial year 2020/21 and to allocate a further £2000.00 in the 2020/21 budget if requested.

#### 38/20 COUNCIL POLICIES & COMMITTEE TERMS OF REFERENCE

The Council considered the policies and terms of reference presented.

**Resolved:** To adopt the Hall Hire Dispensation Policy, Health & Safety Policy, Training and Development Policy, all policies within the General Data Protection Regulations and the Human Resources Committee Terms of Reference.

## 39/20 COMMUNITY HUB REPORT

The Clerk explained that it is a requirement of applying for a public works loan, that a business case is presented to the Council which sets out financial details and evidences need. The report was compiled following planning permission being granted and the costs of the project identified. The total cost will be £607,896 including VAT, less than the £700,000 originally estimated. £40,000 has been allocated in the budget for 2020/21 to cover the repayments of the loan. The detail for the draft agreement of the Sec 106 funding has been submitted to the Isle of Wight Council. Bank statements will also be sent to the Public Works Loan Board as part of the application process. A transfer of funds has been made from the Council's current account to the deposit account, to demonstrate that the Council is able to make the repayments. A copy of the report is attached.

**Resolved:** To accept the contents of the Community Hub Report and approve the application to the Public Works Loan Board.
