PC04/21 PLANNING APPLICATIONS

4.1 Application No: Application No: 20/02179/FUL

Location: 30, 32A and 34A Castle Street East Cowes Isle of Wight PO32 6RD

Proposal: Change of use of tattoo parlour (30 Castle Street) and first floor residential (32a and 34a) to

dental studios (to include attic space)

The Council considered this application. Some concerns were raised about the narrowness of the pavement outside the premises for mobility scooters. It was noted that this application is for the expansion of an existing business. As there was no majority decision no comments were able to be submitted.

4.2 Application No: Application No: 20/02233/FUL

Location: Kingston Farm Beatrice Avenue East Cowes Isle of Wight PO32 6LL

**Proposal:** Proposed construction of 8 dwellings

The Council considered the application and raised concerns about issues of visibility, inadequate footways, and access for emergency and refuse vehicles on the access road. They endorsed the comments of Island Roads.

**Resolved:** The Council did not support the application due to comments made by Island Roads.
