113/23 APOLOGIES FOR ABSENCE

There were apologies from Councillor Hendry who was attending a Governors Meeting at Holy Cross RC Primary School and Cllr Lake who had work commitments. Apologies were also received from the Assistant Clerk who was unable to attend due to contracting the covid virus.

114/23 DECLARATIONS OF INTERESTS

- 2.1 Cllr Reardon declared a non-pecuniary interest as a member of the East Cowes Community Partnership and East Cowes Business Association. Cllr Love declared a non-pecuniary interest as an IW Councillor and as a member of the East Cowes Community Partnership and East Cowes Business Association.

115/23 MINUTES

116/23 COUNCILLOR RESIGNATION

117/23 WATERFRONT/LUF REGENERATION

5.1 TR, KL, SL attended zoom meeting on Wednesday, good news and bad news. KL felt it was a good meeting, but no resolutions were made. TR worries about under the prom building, structural engineers saying that it may not be safe to have people under the prom so need to look at options to reinforce. KL concerned about hold ups on Albany Green as it is quite a tight timescale. TR will be following up as we need to ensure the public realm section is

delivered as promised. MW worried the IW Council may run out of money if the project prolongs. TR and KL believes IW Council may get top up funding from government. KL said that the first round of expression of interest from Maresfield carpark were unsuccessful and IW council accepted there was risk due to Toxic contamination of land, KL has asked IW Council re-tender the contract.

118/23 FLOATING BRIDGE

KL review is underway, confident in those conducting the review and that this will be brought back to IW Council once completed as it is an Investigation into cost effectiveness, continued costs and how much it will cost to replace it.

KL proposed to Write to the IW Council to ask at their earliest convenience to share the report with the ECTC before going to the public domain. TR seconded this and all member in support.

MW requested we follow up on the bus passes for children travelling to and from school as agreed by the previous cabinet member with new cabinet member, Jonathan Bacon.
